

# INSPIRE AND SUCCEED 2023 SYDNEY

## TERMS AND CONDITIONS

### 1. Terms and Conditions

- (a) You are entering into a transaction (the **Transaction**) with Success Resources Australia PTY LTD (herein after referred to as 'SRA') to purchase a private event known as the 'Inspire & Succeed', entitling you to the inclusions set out in section 3 below.
- (b) By proceeding with the Transaction and making a payment, you confirm that you:
- (i) have read, understood, and agree to these terms and conditions.
  - (ii) agree to the privacy policy of SRA – <https://success-resources.com.au/privacy-policy.html>
  - (iii) agree to the conditions of entry set by the venue at which the Inspire & Succeed will take place, being [Conditions Of Entry | Venue Information | ICC Sydney](#)
  - (iv) acknowledge and understand it is incumbent upon you to provide SRA with full and accurate details of each attendee as required under section 4, failing which you may not receive the benefits to which you may otherwise be entitled.
  - (v) agree that whilst the advertised line up & agenda is correct at release, it is subject to change without notice and that you will have no claim against SRA either for a refund or for any other claim whatsoever.
  - (vi) Understand that Inspire & Succeed is a private live seminar for people looking to create multiple streams of income and improve their business strategy, hosted by SRA. During inspire & Succeed, as well as being provided with training and other content, attendees will be given the opportunity to purchase further training and services they may find valuable. ### 2. Payment

- (a) You agree:
- (i) to pay SRA in full, when placing an order to purchase Inspire & Succeed.
  - (ii) until payment has been completed in full, you will not be entitled (nor able) to receive any of the inclusions associated with your purchase of Inspire & Succeed.
- (b) All pricing is in Australian Dollars and includes local taxes.

### 3. Inspire & Succeed Inclusions

- (i) Access to Inspire & Succeed on the 7<sup>th</sup> of December 2023
- (ii) Inspire & Succeed workbook
- (iii) Digital tool kit delivered after attending the Inspire & Succeed
- (iv) Platinum ticket holders only will have a 1 on 1 photo with Sir Richard Branson.

### 4. Requirements of Purchase

- (a) A name, contact number & unique email address will be required for each ticket purchase of Inspire & Succeed.
- (b) Attendee information must be provided at least 7 days in advance of Inspire & Succeed.
- (c) When entering the [ICC Sydney](#) photo identification may be requested & must match the name on the ticket to guarantee entry.

### 5. Cancellation Rights

- (a) Note that there is no cooling-off period and payment for a Transaction is not refundable.
- (b) If Inspire & Succeed is postponed for any reason, your inclusions will apply to the rescheduled event. A rescheduled event will be provided to you before December 7<sup>th</sup>, 2025.
- (c) If Inspire & Succeed is cancelled for any reason, you will be entitled to a refund of the Inspire & Succeed purchase but will have no other claim of any nature arising out of such cancellation.
- (d) Inclusions not used are not able to be swapped or exchanged for credit.
- (e) If you purchase Inspire & Succeed via the telephone, you will have 10 business days from the date of purchase to cancel your purchase & obtain a full refund. Requests must be made in writing to [info.au@srglobal.com](mailto:info.au@srglobal.com) for a refund to be considered.
- (f) Should you qualify for a refund, the amount will be refunded within 30 business days from cancellation.

### 6. Inspire & Succeed Resale

- (a) The re-advertisement or re-sale of Inspire & Succeed inclusions is strictly forbidden.
  - (b) If any inclusions of Inspire & Succeed are found to be re-advertised or for re-sale SRA reserves the right to cancel all inclusions with no refund provided.
  - (c) Only purchases made directly through SRA for Inspire & Succeed will be guaranteed access to the inclusions listed in section 3.
- Scalping warning: The resale of inclusions in certain circumstances is governed by ticket sales legislation and may attract criminal penalties.

## **7. Force Majeure**

- (a) If Inspire & Succeed has to be re-scheduled, postponed or cancelled as a result of an act of God, Government legislation, public health orders, an inevitable accident, power cut, fire, blackout, flood, COVID-19, pandemic, injury, death or any other calamity, or if by reason of strikes, or lockouts, or any other events beyond the direct control of either party, SRA reserves the right to postpone and reschedule Inspire & Succeed and the provisions of section 5(b) or 5(c), as the case may be, will apply.
- (b) SRA reserves the right to alter the venue, speakers and amend the agenda due to circumstances outside of its control.
- (c) SRA will not be liable in any manner whatsoever for any cancellation or postponement of the Inspire & Succeed because of Force Majeure or a change of venue or amendment to the agenda arising out of this clause 7.

## **8. Privacy and your security:**

- (a) SRA will collect personal information including but not limited to name, contact details, email address and postal address. This information will only be shared with approved partners to provide access to Inspire & Succeed and enhance your Inspire & Succeed experience.
- (b) You acknowledge and agree that SRA may disclose and use your personal information in accordance with the SRA privacy policy available at <https://success-resources.com.au/privacy-policy.html>
- (c) Should you not wish to appear in any promotional or marketing materials you must notify us via [info.au@srglobal.com](mailto:info.au@srglobal.com) before the date of Inspire & Succeed.

## **9. Filming:**

- (a) You acknowledge and agree that portions of the Inspire & Succeed may be recorded, and that SRA shall own any recordings that can be used at their discretion for promotional or marketing purposes.
- (b) You agree not to record any part of Inspire & Succeed. Failure to comply with this directive could lead to your participation in Inspire & Succeed being revoked with no refund or credit being provided.
- (c) You may not use recordings from Inspire & Succeed for commercial purposes without the prior written consent of SRA which may be withheld in our absolute discretion.
- (d) Without derogating from the above, materials distributed by SRA as part of Inspire & Succeed may not be distributed or re-produced.

## **10. Inspire & Succeed Information**

- (a) All notices or other communications must be made to [info.au@srglobal.com](mailto:info.au@srglobal.com)
- (b) to prevent exposure to possible adult themes and/or use of adult language (including obscenities) we recommend that persons under age 16 do not attend Inspire & Succeed.

- (i) Tickets to Inspire & Succeed are unable to be transferred to an alternative date or services offered by SRA.
- (j) All attendees must act and behave in a respectful way to fellow attendees, staff, and speakers. Failure to do so may result in removal from Inspire & Succeed without a refund provided.
