Terms and Conditions

Engagement

1. (a) Thank you for accepting our offer to present the Diamond Titanium Membership to you. By placing an Order, you acknowledge that you have read these Terms and Conditions and agree that the placement of an Order, together with these Terms and Conditions, forms a contract between you and Success Resources Australia Pty Ltd and that you agree to our privacy policy - <https://success-resources.com.au/privacy-policy.html>

For the duration of the private live seminars as part of the Diamond Titanium Membership, Success Resources Australia Pty Ltd will consider the location and venue of the live seminar as their normal place of business.

e) Any inclusions listed in term 1 (c) not used within the timeframe will be unable to be transferred, exchanged, or refunded.

2. Delivery of The Diamond Titanium Membership:

(a) Access to The Diamond Titanium Membership seminars can be provided as per the below:

- (ii) Ongoing Mentoring or coaching
- (iii) Tangible products
- (iv) Online or virtual resources

(b) Information on The Diamond Titanium Membership will be sent via email prior to each seminar, with instructions on how to register for each The Diamond Titanium Membership seminar.

(c) It is the responsibility of the purchaser to provide all contact information for each ticket holder and to register and attend Diamond Titanium Membership seminars

(d) Each Diamond Titanium Membership seminar purchased will receive access to seminars as per term 1(c)

(e) The delivery of Diamond Titanium Membership will not begin until the full balance has been paid to Success Resources Australia Pty Ltd, or whereby an instalment repayment structure has been agreed.

(f) Diamond Titanium Membership seminars are live, and no recording is provided.

3. Investment and Payment

You agree to pay Success Resources Australia Pty Ltd:

(a) In full, if no payment plan has been agreed with Success Resources Australia Pty Ltd when placing an order for Diamond Titanium Membership.

(b) if a payment plan has been agreed with Success Resources Australia Pty LTD, the installment amount in full as per the amount and date agreed when placing an order for Diamond Titanium Membership.

(h) Payments made online may be subject to an additional 1.85% payment processing fee and a \$3.30 handling fee for Diamond Titanium Membership. The payment processing fee is calculated as a percentage of the total value of Diamond Titanium Membership.

4. Cancellation Rights

(a) If you advise Success Resources Australia Pty Ltd in writing via email to info.au@srglobal.com within 3 business days of making a payment (in full or installment) that you do not wish to receive Diamond Titanium Membership then this agreement will be terminated. On the provision that you have not yet accessed (portion or all of) Diamond Titanium Membership, Success Resources Australia Pty Ltd will refund you all monies you have paid as part of this agreement.

(b) Success Resources Australia Pty Ltd does not accept 3rd party cancellations, cancellations to alternative email address or any other cancellation method other than stated above.

(c) For requests made after the 3 business days, no refund will be provided should the service of Diamond Titanium Membership be available to you.
