Terms and Conditions

Engagement

1(a) Thank you for accepting our offer to present the Gold Titanium Membership to you. By placing an Order, you acknowledge that you have read these Terms and Conditions and agree that the placement of an Order, together with these Terms and Conditions, forms a contract between you and Success Resources Australia Pty Ltd and that you agree to our privacy policy - <https://success-resources.com.au/privacy-policy.html>

During the live seminar, as well as being provided with training and other content, attendees will be given the opportunity to purchase further training, seminar services they may find valuable. For the duration of the private live seminars as part of the Gold Titanium Membership, Success Resources Australia Pty Ltd will consider the location and venue of the live seminar as their normal place of business.

e) Any inclusions listed in term 1 (c) not used within the timeframe will be unable to be transferred, exchanged, or refunded.

2. Delivery of The Gold Titanium Membership:

(a) Access to The Gold Titanium Membership seminars can be provided as per the below:

- (ii) Ongoing Mentoring or coaching
- (iii) Tangible products
- (iv) Online or virtual resources

(b) Information on The Gold Titanium Membership will be sent via email prior to each seminar, with instructions on how to register for each The Gold Titanium Membership seminar.

(c) It is the responsibility of the purchaser to provide all contact information for each ticket holder and to register and attend Gold Titanium Membership seminars

(d) Each Gold Titanium Membership seminar purchased will receive access to seminars as per term 1(c)

- (e) The delivery of Gold Titanium Membership will not begin until the full balance has been paid to Success Resources Australia Pty Ltd, or whereby an instalment repayment structure has been agreed.

3. Investment and Payment

You agree to pay Success Resources Australia Pty Ltd:
