Terms and Conditions

Engagement

1 (a) Thank you for accepting our offer to present the Silver Titanium Membership to you. By placing an Order, you acknowledge that you have read these Terms and Conditions and agree that the placement of an Order, together with these Terms and Conditions, forms a contract between you and Success Resources Australia Pty Ltd and that you agree to our privacy policy - <https://success-resources.com.au/privacy-policy.html>

For the duration of the private live seminars as part of the Silver Titanium Membership, Success Resources Australia Pty Ltd will consider the location and venue of the live seminar as their normal place of business.

e) Any inclusions listed in term 1 (c) not used within the timeframe will be unable to be transferred, exchanged, or refunded.

2. Delivery of The Silver Titanium Membership:

(a) Access to The Silver Titanium Membership seminars can be provided as per the below:

- (iii) Tangible products
- (iv) Online or virtual resources

(c) It is the responsibility of the purchaser to provide all contact information for each ticket holder and to register and attend Silver Titanium Membership seminars

(d) Each Silver Titanium Membership seminar purchased will receive access to seminars as per term 1(c)

- (e) The delivery of Silver Titanium Membership will not begin until the full balance has been paid to Success Resources Australia Pty Ltd, or whereby an instalment repayment structure has been agreed.

3. Investment and Payment

You agree to pay Success Resources Australia Pty Ltd:

4. Cancellation Rights
