Terms and Conditions

1. Engagement

(b) Your purchase will include:

3. Payment:

4. Cooling Off Period

(a) If you advise Success Resources Australia Pty Ltd in writing via email to tickets@unleashthepowerwithin.com within 3 business days of making a payment (in full or installment) that you do not wish to receive Unleash the Power Within Virtual 2021 then this agreement will be terminated. On the provision that you have not yet accessed (portion or all of) Unleash the Power Within Virtual 2021, Success Resources Australia Pty Ltd will refund you all monies you have paid as part of this agreement.

(b) Success Resources Australia Pty Ltd does not accept 3rd party cancellations, cancellations to alternative email address or any other cancellation method other than stated above.
